Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

Center Stage Dance Company, Inc. is taking every precaution to screen all employees and dancers entering the building however COVID-19 has been proven to be asymptomatic in some persons. Further, **attending Center Stage Dance Company could increase** your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending Center Stage Dance Company and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

By signing this agreement & checking the following statements, I agree that my child or myself DO NOT exhibit any of the following new or worsening signs or symptoms of possible COVID-19:

Cough Muscle Pain Sore Throat Diarrhea Chills
 Shortness of breath or difficulty breathing Repeated shaking with chills
 Headache Loss of Taste

Known close contact with a person who is lab confirmed to have COVID-19 in the last 14 days

Feeling feverish or a measured temperature greater than or equal to 100.0 degrees Fahrenheit.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at Center Stage Dance Company. On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless Center Stage Dance Company, Inc., its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Center Stage Dance Company, Inc., its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any of Center Stage Dance Company's programs.
